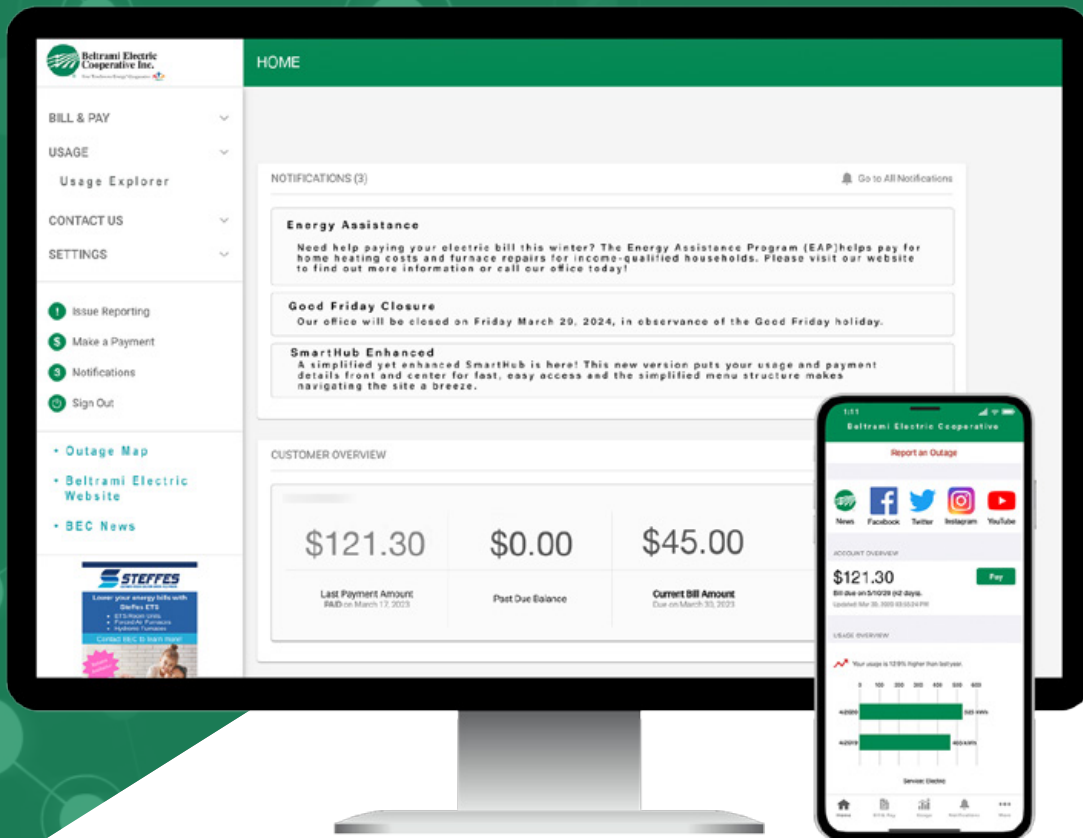

Reliable power for today – and for tomorrow

Times have changed. Reliability is an afterthought to many in the United States. We pay the bill and the lights come on when we flip the switch. Honestly, many of us don't think much further than that. As consumers, we haven't needed to. As utility planners, it's imperative. Reliability has been so good for so long that we sometimes take for granted the monumental amount of work, planning, coordination and investment that makes up this engineering wonder called the electric grid. But recent headlines have begun to shed light (pun intended) on what is becoming a more fractured network of generation resources, and the importance of baseload generation and a robust transmission system required to keep the lights on. Recent headlines are a grim reminder that we can't take our eye off the ball, even for a moment, when it comes to safety and the reliability of our nation's electric grid.

Your team at BEC is always looking ahead, exploring ways to innovate and utilize innovative technologies to improve our services. As our nation increasingly relies on electricity to power the economy, keeping the lights on has never been more important, and it's becoming more challenging. We're committed to powering – and empowering – our community at a cost local families and businesses can afford.

So how are we working to ensure reliable and affordable power while adapting to a changing energy landscape, legislative mandates, and our members' evolving needs?

One critical component of reliable power is the mix of energy resources used to generate the electricity that keeps the lights on in the communities we serve. You may not realize it, but with the exception of our community solar array, BEC doesn't generate electricity. Instead, we purchase it from our wholesale energy provider, Minnkota Power Cooperative, and from there, we distribute it to our members.

We're increasingly using more electricity generated from renewable energy sources, but we still depend on a diverse energy mix to ensure reliable power that's available to

our members whenever they need it. Our current energy resource mix is made up of 56% coal, 34% wind, 8% hydro and 2% from other sources.

To help keep the lights on in a carbon-managed world, Minnkota Power Cooperative is exploring a carbon capture and sequestration project called Project Tundra.

Project Tundra would capture 4 million tons of



CO₂ annually and allow our generation and transmission cooperative to continue to provide baseload electricity – so important to maintain a reliable electric grid.

In addition to managing a reliable energy mix, we're using technology to enhance our local grid, limit service disruptions and improve outage response times.

Advanced metering technology, also known as AMI, enables two-way communication between the co-op and consumers. In the event of a power outage, AMI can help our crews respond to outages and can even analyze damaged or tampered meters. AMI helps BEC save money with near real-time data and ultimately improves power reliability for our members.

Your cooperative maintains more than 3,500 miles of line, of which 75% is underground, and we're a leader in the state.

For the remaining 900 miles of overhead line, we implement a proactive vegetation management program to increase safety and reduce service disruptions. Overgrown trees and brush can be conductors of electricity, and a good vegetation management program can reduce outages caused by falling trees and limbs, as well as avoid safety hazards for our crews and the general public. We can't prevent bad weather, but we can reduce outages caused by falling limbs and trees.

As we focus on 2024, BEC will continue working to provide the safe, reliable and affordable electricity you expect and deserve – for today and tomorrow.

BOARD MEETING HIGHLIGHTS

Beltrami Electric Cooperative's board conducted its regular monthly meeting Tuesday, Jan. 23, 2024. A quorum of directors was in attendance.



The following reports were given at the meeting:

- President and CEO Echternach and the board discussed recent safety successes and observations.
- NRECA President Tony Anderson presented an update on the National Rural Electric Cooperative Association and the Cooperative Family Fund.

- President and CEO Echternach made his monthly report, including a recap of 2023, legislative priorities and issues affecting the cooperative and meetings attended.
- Arlene Hogquist presented December's preliminary financial report.
- Mike Birkeland and Bob Gregg reviewed the annual net metering and cogeneration report and associated filings.

- President and CEO Echternach presented the succession plan.
- Directors and President and CEO Echternach discussed upcoming meetings and events.

The following actions were taken at the meeting:

- Approved the consent agenda.
- Approved the annual net metering and

- cogeneration report, associated filings and rates.
- Appointed all eight directors as the Minnkota Power and Square Butte annual meeting voting delegates.
- Approved director and President and CEO expenses.

The next board meeting will be held Wednesday, March 27, 2024.

Voices for GRID RELIABILITY

America's electric grid is beginning to face significant reliability risks. As more baseload and dispatchable power plants are retired without adequate replacement, the margin for error is becoming razor thin.

Minnkota Power Cooperative, Beltrami Electric Cooperative's wholesale power provider, maintains a diverse resource mix that includes coal, wind and hydro power that contribute to a reliable grid. However, the Minnkota system is connected with other utilities across the central United States – from North Dakota and Minnesota down through Louisiana. Challenges in other parts of the country can contribute to reliability issues in our region.

Regulators, policymakers, utilities and others are voicing their concerns about transitioning too quickly toward intermittent resources – like wind and solar – without retaining the stability provided by coal, nuclear and natural gas power plants. Here's what some of the major entities responsible for reliability are saying.

Federal Energy Regulatory Commission (FERC)

North American Electric Reliability Corporation (NERC)

Minnkota Power Cooperative (MPC)

HOW DOES CARBON CAPTURE WORK?

You've likely heard about Project Tundra, a carbon capture and storage initiative being pursued by our wholesale power supplier, Minnkota Power Cooperative, and its partners. If successful, this technology would capture approximately 4 million tons of carbon dioxide (CO₂) every year and store it safely and permanently underground – creating a more sustainable power mix for Beltrami Electric.

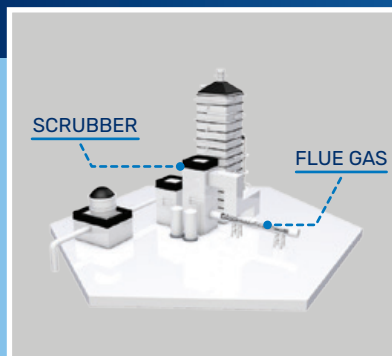
So how does the “capture” portion of this process work? It's quite simple...

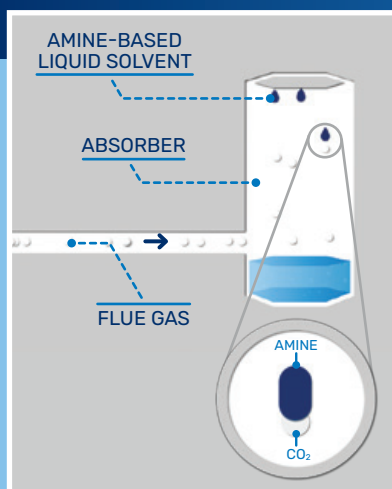

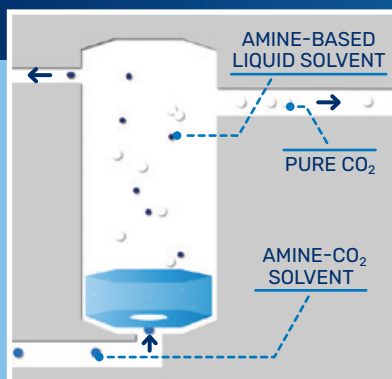
STEP 1

Flue gas from the coal-based power plant is diverted to a scrubber, which cools the gas and removes impurities.



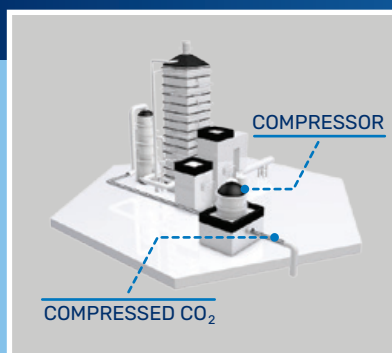
STEP 2

The gas is sent to an absorber unit where the CO₂ capture takes place. As the gas rises through the unit, it comes in contact with an amine-based liquid solvent. The amine bonds with the CO₂ and removes it from the flue gas.



STEP 3

After the amine solvent has absorbed the CO₂, it is sent to a regeneration unit. There, heat is used to break down the CO₂ bonds with the solvent, releasing pure CO₂.



STEP 4

Finally, the CO₂ is sent to a compressor where it is prepared for deep geologic storage.

CAN YOU EXPLAIN THE CHARGES ON MY ELECTRIC BILL? (PART 1 OF 3)

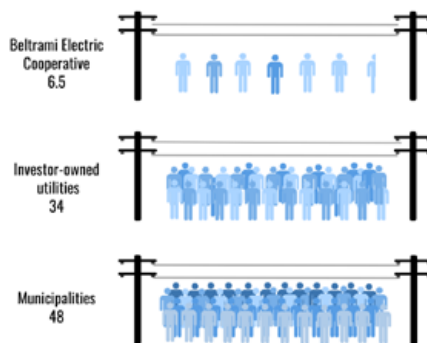
Yes! Simply put, your bill is split into two parts: fixed cost and variable cost. Details about the fixed charge are covered this month and the variable cost will be explained next month.

The monthly Access Charge is a fixed cost and is there to provide access to reliable electric service. It is designed to cover expenses like power lines, transformers, poles, meters, right-of-way clearing, and maintaining and improving the distribution

system for safe and reliable service. It also supports fleet and equipment used to restore your power, facility, administrative responsibilities, and having staff available 24/7 to get your power back on during outages. These costs exist whether or not any electricity is being used.

Fixed charges vary by utility and are based on density (number of miles of line compared to consumers). Investor-owned and municipal utilities in cities and metro areas (like Otter Tail Power Co. or Xcel Energy) have fewer miles of line to maintain and more consumers to share the fixed costs. Electric co-ops that serve rural areas have more miles of line and fewer consumers to share those fixed costs.

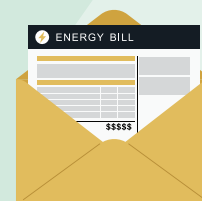

All digging requires the 48-hour notification so that buried telephone line, television cable, pipelines, utility electric lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.
