Legislative update

Permitting

With the carbon free by 2040 bill that passed last session, the energy committees are focused on proposals to better align the permitting process with the demands of the clean energy transition mandated by the legislature. SF4784 would make the permitting process more efficient.

No new mandates

Several bills have been introduced that would impose mandates on cooperatives if passed. HF 3895 would impose certain requirements on cooperative governance boards related to public meetings, board elections and information dissemination. We feel co-ops are best governed by their members and not legislators in St. Paul.

Property tax on co-op distribution infrastructure (SF1242/HF1171)

Over the past few years, the Department of Revenue has begun to exclude co-op-owned rural meters and streetlights (attachments and appurtenances) from a rural electrification property tax exemption that has been in place since 1939. A hearing on a property tax clarification bill with language solidifying our exemption was held in late February. We are optimistic the bill will be included in the Governor's tax bill.

Efficiency and Conservation Optimization Act (ECO) (SF4562/HF4574)

Several years ago, the legislature updated the

state's Conservation Improvement Program (CIP) renaming it the Energy Efficiency and Conservation Optimization Act (ECO). The ECO Act was intended to create greater flexibility in utility energy efficiency and conservation programs and change the primary focus of the program from a spending program to a savings program. SF4562/HF4574 would streamline the administrative burden of ECO and allow incentives for efficient fuel switching.

Excavation (SF2723/HF2717)

This bill would change the process for locating underground utilities for excavation projects, a major concern for utilities. We will continue to monitor this to ensure utility locating is done safely and your cooperative is not put at risk from changes to existing statutes.

Nuclear

The Senate Energy Committee heard SF 3120, which requires the Department of Commerce to conduct a study evaluating the potential costs, benefits and impacts of advanced nuclear reactors operating in Minnesota.

We continue to engage on your behalf on issues affecting your cooperative. I'm pleased to report that our local legislators are very supportive of your electric cooperative. Thank you, Sen. Green, Sen. Utke, Sen. Eichorn, Rep. Bliss and Rep. Grossell for your support.

Small Change, Big Impact: Beltrami Electric's **Operation Round Up® transforms communities**

The "power of change" has been at work in BEC's service area since 2016, thanks to the generosity of members who participate in our Operation Round Up[®] (ORU) program.

Participating members volunteer to have their monthly electric bill rounded up to the next dollar, contributing the excess change to the charitable ORU Trust. Operation Round Up allows co-op members to pool their resources to make a substantial impact on our local communities.



The impact of BEC's Operation Round Up program resonates across a wide spectrum of community needs. Members' contributions have funded essential equipment for police

K-9 and fire departments, supported educational initiatives and extracurricular programs for students, and provided financial assistance to organizations such as Scouts, Beltrami County Historical Society, Headwaters Science Center and local food shelves.

Among the beneficiaries of the program is the North Country First Responders (NCFR), a dedicated group of volunteers trained as Emergency Medical Responders (EMR) and Emergency Medical Technicians (EMT). Since 1992, the NCFR has been responding to emergencies in a vast area covering 27 townships in Beltrami County and four townships in northern Hubbard County.



The NCFR received a \$1,500 ORU grant in October, enabling them to acquire backpack-style rapid response medical bags for their volunteers. These bags play a pivotal role in enhancing response times to remote locations, community events, confined spaces and situations where seconds can make a difference. Tara Hokuf, a member of the NCFR, expressed gratitude, stating, "The generous donation from Beltrami Electric's Operation Round Up program this fall provided us the opportunity to purchase 'rapid response bags' for our members. These bags provide a distinct advantage in our response times."

The NCFR emphasizes the ongoing need for community support to ensure they can continue to strengthen their membership and deliver crucial emergency care in the face of rising medical equipment and supply costs. Their mission of providing confident, competent and compassionate pre-hospital emergency care aligns with the ORU program's broader goal of improving the quality of life in the region.

All contributions from ORU members directly benefit local community organizations, with an average monthly contribution of 50 cents or \$6 a year. The maximum yearly contribution is just \$11.88. Nonprofit organizations in the community are eligible to apply for ORU grants, and the Trust Board, consisting of five BEC members, convenes twice a year to review applications and allocate funds.

As BEC's Operation Round Up program continues to thrive, its impact on our communities grows exponentially. (0-OP VALUES: THE ESSENTIALS -TODAY, TOMORROW AND ALWAYS



"The grid" is made up of nearly 4,000 diverse private, not-for-profit, and public organizations that transmit electrons over power lines and employ people that power our communities, our business and industry, and our country.

SERVING THE COUNTRYSIDE

Electric cooperatives are a big part, and the not-forprofit part, of this picture. There are more than 900 distribution co-ops like Beltrami Electric across the United States. And every co-op is homegrown and locally owned.

We are governed by those we serve. And we serve resilient, pull-yourself-up-by-your-bootstrap, communities. We provide electricity to areas where people and power poles are separated by vast tracts of timber, row-cropped fields, pastureland or one of our 10,000 walleye-filled lakes.



TIPPING THE CAP TO OUR PAST

Electric co-ops were organized by our forefathers and mothers. We're set up to operate "at cost." Any margin that is earned either goes back to our lenders to meet our loan obligations – or it goes back to members in the form of capital credits.

In other words – if you're a member of the co-op, you receive cash back through capital credits and your share of the margin over time. In the process, you're also making an investment in your local co-op. Your monthly payment for electric service supports building, operating and maintaining a safe and reliable electric distribution system for the communities and members we serve.

While capital credits grow and are paid back over time, co-op costs are spread over time and comprise the basis for electric rates. It's a business model that spans generations – because most of our equipment like poles, wires and transformers lasts for generations. Thus, the costs – and the benefits – are spread and shared across generations of members.

HOLDING THE LINE ON RATES

Thankfully, due to hard work, diligence and the wise use of member resources, Beltrami Electric hasn't had a rate increase in six years. It's especially notable given supply chain and inflationary challenges over the course of the past few years.

To do it while maintaining some of the best electric reliability and safety numbers in the state is even more of an accomplishment. That's news worth sharing – and acknowledging – today, tomorrow and always.

CAN YOU EXPLAIN THE CHARGES ON MY BILL? (PART 2 OF 3)

The **PURCHASED POWER ADJUSTMENT** is a direct pass-through of changes in the average cost of wholesale power purchased from Minnkota Power Cooperative for both regular and off-peak rates. (*The adjusted cost could either be a decrease or an increase*). This allows

BEC more flexibility when recouping fluctuations in the wholesale energy costs instead of estimating them into an overall electric rate. If you have additional questions contact our office at **218-444-2540** or email **info@beltramielectric.com**.

Yes! Simply put, your bill is split into two parts: **FIXED COST and VARIABLE COST**. We shared details about the fixed cost in the March Northern Lights and will cover the variable cost this month.

The electricity you use is a **VARIABLE** cost and is measured in kilowatt-hours (kWh). We all know that some months we use more electricity than others, especially when the temperatures are extremely hot or cold.

o A **KILOWATT-HOUR (kWh)** is the measurement of electricity used. One kWh is equal to 1,000 watts used continuously for one hour. The higher the watt rating on electrical devices, the more electricity it uses.

EXAMPLE:

A standard plug-in space heater uses 1,500

watts and runs for 8 hours a day for 30 days.

KWH USE = 1,500 watts x 8 hrs. x 30 = 360

YOUR COST = 360 kWh x \$.12 = \$43.20/month
