Anyone who plans to dig is required by law to notify the state of their intentions at least 48 hours in advance.

All digging requires the 48-hour notification so that buried telephone line, television cable, pipelines, utility electrical lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.

### Cold Weather Expo

I'd like to thank everyone who attended our second annual Cold Weather Expo on Nov. 10. Our staff developed this event as a way to help our members prepare for the upcoming heating season and the challenges it brings. Several employees from both member services and energy services visited with members about topics ranging from the Cold Weather Rule, to off-peak heating system requirements, and provided information on how to monitor and track their electric usage with our free web-based MyMeter program. In addition, many local agencies were on hand to answer any questions members may have had about the programs and services they offer. If you missed it but have questions on the above topics, feel free to stop in the office anytime.

### Clean Power Plan

The Environmental Protection Agency (EPA) published its new carbon rule in the Federal Register at the end of October. On Oct. 23, coinciding with the filing in the Federal Register, 24 states filed lawsuits challenging the EPA's authority of this regulatory overreach. The states and industry

stakeholders are asking the appeals court to prevent "irreparable harm" by halting implementation of the regulation while legal proceedings are carried out. If you recall from our October newsletter, when the EPA issued its Clean Power Plan in August, it looked nothing like what was proposed just a year earlier. What was originally going to be an additional 11 percent reduction in carbon dioxide emissions by 2030 morphed into a 45 percent reduction instead. The EPA is no longer giving credit to North Dakota

for being proactive in reducing CO<sub>2</sub> emissions. None of Minnkota's investment in wind energy will count toward the EPA's standard now simply because it was installed before 2013. Now, without changes to this plan, the only way North Dakota will be able to get to a 45 percent reduction is by either shutting down some of the state's coal plants, or

operating them at drastically reduced levels. Prematurely shutting down these plants would be like boarding up your home and moving out into a different home, while still being responsible for mortgages on both. ## You get the credit

Electric cooperatives aren't like other utilities – you, as a consumer and a member, own a portion of the business. And one benefit of that membership involves the allocation of excess revenue, called margins, in the form of capital credits.

Electric cooperatives operate at cost – collecting enough revenue to run and expand the business, but without the need to raise rates like investor-owned utilities (IOUs), that generate profits for distant shareholders. When Beltrami Electric closes its books, excess margins are allocated back to you and other members as capital credits. As the co-op's financial position permits, the co-op retires, or pays, the capital credits back to our members. See page 4 for more information.

Beltrami Electric's board of directors has approved the 2015 retirement and allocation of approximately \$1.2 million in capital credits to more than 15,000 active and former members across our service area. Overall, more than \$20 million has been returned back to the membership since the co-op's inception.

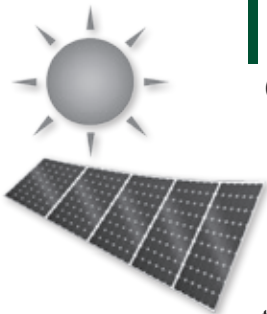

## Northern Solar by Beltrami Electric Cooperative

(Update as of Nov. 10, 2015)



In June of this year, we announced our plans to construct an 80-kilowatt (kW) Direct Current (DC) solar garden array on our headquarters property. The array will consist of 192 photovoltaic panels rated at 400 watts each. The cost for members who wish to subscribe to the Northern Solar project is

\$1,295 for a full panel's output or \$647.50 for a half panel's output. In return, members will be allocated the energy produced (kWh) by their subscribed panel(s) to offset their kWh on their electric bill.

The project will not move forward until we are able to get at least 50 percent (96 panels) subscribed. As of the beginning of November, we have 47 panels subscribed. In talking to members, we do feel there is enough interest for this project to succeed, but until we get at least another 49 panels subscribed to, the exact time frame for construction is unknown.

## The power of



It started as a simple idea 27 years ago at one co-op in South Carolina. Just round up the co-op member's electric bill to the next dollar, and then use it to do good work in your community. Today, hundreds of electric co-ops throughout the country use this idea to help members and organizations close to home.

All co-ops adhere to the seven cooperative principles, including "Concern for Community." The Operation Round Up program is the perfect embodiment of this core principle. The average co-op member donates \$6 with a maximum possible contribution of \$11.88 per year. This may not seem like a large amount, but when combined with 16,000+ members, it adds up to make a significant impact.

Each co-op decides how they want to operate the program, and the vast majority is governed by a board of volunteers that is different from the board of directors for the electric co-op. This ensures that the decisions are made in the best interest of the community. The program is always voluntary, and at any time, members can change their minds about participating. Once folks see the good work the program does in their community, they almost always keep contributing.

Over the years, millions of dollars have been collected and distributed for a wide range of activities. Examples of this include assisting the local food shelf, animal shelter, providing funds to the local fire department to assist in getting a needed piece of equipment, or dozens of other humanitarian efforts that bring electric co-ops even closer to the communities we serve.

While each co-op must respond to the needs of its members, one of the great attributes of co-ops across the country – and the world – is their willingness to share information about the programs that have been successful. Operation Round Up is a perfect example of that cooperative spirit.

# YOU get the credit!

It's time for you to get the credit – capital credits, that is – for helping build, sustain, and grow your local electric cooperative. This year the board of directors for Beltrami Electric has approved retiring and paying more than \$1 million in capital credits for more than 15,000 present and former members of Beltrami Electric!

It PAYS to be a member-owner of Beltrami Electric! When you signed up to receive electric service from Beltrami Electric,

you became a member of an electric cooperative. While investor-owned utilities return profits to their shareholders, Beltrami Electric is a member-owned, not-for-profit cooperative, and every year margins are allocated back to the member-owners in the form of capital credits. That's the Cooperative Difference.

## MEMBER PATRONAGE

Beltrami Electric keeps track of how much electricity you purchase throughout the year.



## ALLOCATION

After a year ends, Beltrami Electric distributes your share of the margins for that year to your capital credit account. Capital credits are not payable at the time they are allocated. This normally happens in March for the previous year.

(Margins = PROFIT – EXPENSES)



## ALLOCATED CAPITAL CREDITS


Capital credits increase on your account over a period of time. Beltrami Electric uses the allocated capital credits as a source of equity to build and maintain our electrical system, which in turn helps keep your electric rates low.

Present members who receive a capital credit retirement will see a credit on their statement in late November or early December (depending on the billing cycle). A credit applied to a statement will be listed as "Apply Capital Credit Retirement" under the Detail of Charges (Former members will receive their capital credits via a check in the mail).



## RETIREMENT OF CAPITAL CREDITS

Each year, depending on the financial condition of Beltrami Electric, the board of directors will decide to retire and pay capital credits to present and former members.

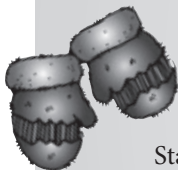

# Board Meeting Highlights

Beltrami Electric's board of directors conducted its monthly meeting Thursday, Oct. 22, 2015. All directors were present except John Lund, who was excused. Also present were General Manager Lynette Nieuwsma and Director of Finance and Member Services Sid Sletten.

**The following reports were given:**

- The manager made her monthly report, including discussion on customer growth, and an update on the cooperative financials. She also presented information on after-hours dispatch options, capital credits with our wholesale accounts and Minnkota Power rates and rate structure.
- Vickie Swanson, manager of Cooperative Development, LLC reported on the history and the future of the business.
- Sam Mason and Lynette Nieuwsma presented draft mission statement, bylaws and articles of incorporation documents for Beltrami Electric Cooperative Trust. Nominations were given by the board of members in their respective districts who have agreed to serve on a five-person board that will administer the Operation Round Up program.
- Sid Sletten presented the August and September financial report, work order inventories and the third-quarter budget and year-end projections. He also reviewed insurance coverage and rates for the headquarters building and equipment and discussed cyber insurance. Workers compensation insurance rates were also reviewed.
- Terry Difley reported on the Minnkota board meeting.
- Rick Coe reported on the Square Butte and the Minnesota Rural Electric Association board meetings.
- The manager presented a revised Neutral to Earth Voltage – Stray Voltage policy.

**The following actions were taken:**

- Approved membership in Cooperative Response Center.
- Adopted the mission statement, articles of incorporation and bylaws of the Beltrami Electric Cooperative Trust and elected the initial board of directors.
- Approved the purchase of cyber insurance for the cooperative.

## A “POWERFUL” trip



**B**eltrami Electric members took two days out of their busy fall schedules to find out more about where their electricity comes from. Our second tour of the year, we filled a bus chartered from Bemidji Bus Line with a wonderful group of members ages 10 to 90.

We left Beltrami Electric's offices at 6:30 a.m. on Sept. 10 and headed to Minnkota Power Cooperative's offices in Grand Forks, N.D. We were treated to some wonderful coffee, warm rolls, donuts and juice. We were then greeted by Mac McLennan, Minnkota's president & CEO, and he talked with us about Minnkota's history and its future. After visiting with Mac, we split into two groups and started the tour of Minnkota. The first stop on the tour was to see the old diesel generators. They were some of the first units to provide power to the area back in the 1940s, with a few actually being repurposed from old navy ships after WWII ended.

The next stop was the print shop. Our members were able to see first-hand where your *Northern Lights* newsletter is produced, printed and shipped and had the chance to meet the great people who provide this service to us. The last stop before leaving Minnkota was to tour the control center. Operators explained to the group the various tools and technology they use to monitor the entire system, which covers 35,000 square miles. After leaving Minnkota, we settled in on the bus and made our way to Casselton, N.D., where we stopped at Pizza Ranch to enjoy a wonderful lunch, topped off with some of their famous ice cream!

Once again, we boarded our bus and headed further into North Dakota. Our next stop on the tour was the Ashtabula Wind Energy Center, named after Lake Ashtabula, located 15 miles northeast of Valley City, N.D. This 366-megawatt (MW) wind farm was developed by Minnkota Power Cooperative, NextEra Energy Resources and Otter Tail Power Company. Minnkota purchases energy from its 217.5 MW allocation through a 25-year Power Purchase Agreement. Members had the opportunity to learn about what it takes to keep the large turbines in working condition, including seeing all the different parts, grease and filters that get replaced during routine maintenance. By the time we left, we had a better understanding of what it takes to keep the

more than 280-plus turbines functioning, and it's more than just wind.

We then headed to our hotel in Mandan, N.D., the Baymont Inn & Suites. We quickly settled in and were treated to a fabulous banquet meal and presentation, sponsored by Minnkota. After the banquet, Minnkota employee Sue Black showed us a video on the 75<sup>th</sup> anniversary of Minnkota.

On Friday, we were up before the sun to enjoy a quick breakfast and fill up our coffee mugs for another day of touring. Our first stop of the day was the Milton R. Young Station, where we all departed the bus for a group photo as the sun came up over the hills of North Dakota. With our shoes damp from the early morning dew, we climbed back onto the bus. Sue Black from Minnkota guided us over to the BNI Coal mine, where we picked up our tour guide Courtney Doll. She directed our driver as we made our way to the coal mine and to BNI's largest dragline, Liberty. There isn't a more "up-close" view than from the cab of the Liberty, standing behind the operator's chair watching him work. From a distance, the massive bucket doesn't seem that big, but once they lowered it to the ground for all of us to see, and members climbed up into it for a photo, they barely filled a few feet inside of it. We left Liberty and proceeded to drive down onto the floor of the pit to get a close-up look at the coal seam and the operators driving the massive 240-ton Kress haulers filled with coal.

We then headed back to the Milton R. Young Station where we were treated to cookies and coffee while we watched a PowerPoint presentation explaining how the plant works. The Milton R. Young Station is comprised of two boilers, Unit 1 and Unit 2. Unit 1 began operation in 1970 and has a maximum output of 250 megawatts. Unit 2 was completed in 1977 and has a maximum output of 455 megawatts. After the presentation, we were given a guided tour of the facility. From there, we headed to the Square Butte Creek Golf Course clubhouse, where we enjoyed a wonderful lunch before we said our goodbyes to our tour guides and headed back to Bemidji.

I'd like to thank everyone who took the time to see where your power comes from. It's always a pleasant and educational trip and a pleasure to meet everyone. If you have never been on the tour before, please consider it for next year. Keep an eye out for next year's tour dates in your *Northern Lights*.
