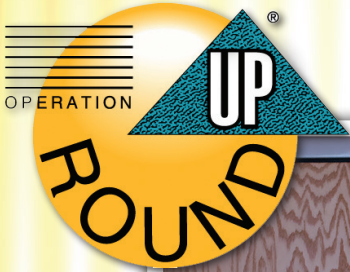

All digging requires the 48-hour notification so that buried telephone line, television cable, pipelines, utility electrical lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.

Operation Round Up®

I have been asking employees and members about what they have accomplished with others that made a big impact that they couldn't have done alone. Whether it was joining a group doing yard cleanup for a senior neighbor, or pitching in to help organize and support a fundraiser for a friend or family member who had recently experienced illness or a tragedy, it is apparent that we can do more when we work together than as individuals. Each of us doing something on our own might not amount to much, but if everyone does a little, we see a big impact in our community.

The concept behind the Operation Round Up program is to extend the principle on which electric cooperatives were built 75 years ago – neighbor-helping-neighbor – and as a Touchstone Energy® Cooperative, we adhere to the seven core principles, one of which is Concern for Community. Of the 44 electric distribution cooperatives in Minnesota, Beltrami Electric remained one of only seven who hadn't already implemented the Operation Round Up program. After hearing about the great success our surrounding electric cooperatives have experienced with this program, as well as the huge impact their members continue to make in their respective communities, our board of directors decided to move forward with this program.

However, we have heard concerns from some of our members about the Operation Round Up program,

and we did forward those concerns on to our board of directors. The board thoroughly discussed those concerns at their February board meeting, along with whether to keep the program as an opt-out program, change it to an opt-in or drop the program altogether. After a very lengthy discussion, our board decided to stay the course with the program as an opt-out program. Over the next few months, we will continue to help our members understand more about their participation in Operation Round Up, as well as how they can opt out of this voluntary program if they choose. We will use several mediums, including your monthly member newsletter, a message on the bills, a separate billing insert, as well as providing the most up-to-date information on our website.

Operation Round Up is a voluntary program that seeks to use small amounts of change from BEC members' electric bills to enact large, community-wide changes. This program's sole purpose is to improve the quality of life for our community. This is one of the things that separates electric cooperatives from other investor-owned utilities and why you are a member and not just a customer. The health and long-term sustainability of our community depends on all of us demonstrating our mutual concern for our community.

That being said, I do realize that not everyone is willing or able to participate in the program at this time. You may opt out of the program by calling our office; or in the future if your situation changes, you may opt back in as well.

Northern Solar

Beltrami Electric Cooperative announced last year that we plan to construct an 80-kW DC community solar garden on the cooperative's headquarters property at 4111 Technology Drive in Bemidji.

Members who wish to subscribe to the Northern Solar project will pay \$1,295 for a full panel's output or \$647.50 for a half panel's output. A 10 percent down payment is required to reserve the panel(s). In return, members will be allocated the energy produced (kWh) by their subscribed panel(s) to offset the kWh on their monthly electric bill. The projected annual average of a panel is 450 kWh, based on the Solar Advisor Model from the U.S. National Renewable Energy Laboratory.

We hope to start breaking ground this spring if we get enough of the solar panels subscribed. We are still receiving interest from members and as of Feb. 10, we now have 62 panels subscribed. However, we need at least 96 panels subscribed before we can move forward with the

project, so if you are interested and have not yet signed up, please do so soon. For more information or to request a contract, you may contact our office or go to our website www.beltramielectric.com.

Rates

The last couple of months I have talked about rates, which is never a fun topic when looking at an increase. As I have mentioned in earlier letters, we will be having a wholesale power increase effective April 2016. With nearly 70 percent of our costs going to wholesale power, this will have an impact on our rate structure. Just how much and what kind remains to be seen.

We have recently closed our 2015 financial books and will be working on a cost of service and rate study, to be conducted by an independent outside consultant. A cost of service study will help us to determine what total revenue is needed and to what rate components and rate classes. We will continue to communicate as we know more.

Member district meetings in March

We invite all Beltrami Electric

Cooperative members who live in Districts one (1), five (5) and eight (8) to attend their area's district meeting in March. This is your opportunity to be updated on your cooperative and nominate your district's candidates for the board of directors, which will be voted on by mail next month. The election results will be announced at the annual meeting scheduled for April 21 at the Bemidji High School. Beltrami Electric selects new CEO

Operation Round Up[®]

In May, Beltrami Electric Cooperative (BEC) will be joining 37 other Minnesota electric cooperatives and hundreds more around the nation that currently have an Operation Round Up program (see map of Minnesota participating cooperatives on this page). This program was originally started by Palmetto Electric Cooperative in South Carolina 27 years ago. Since that time, cooperative members around the nation have invested millions of dollars back into their communities, and have discovered that by working together they have the power to make a significant impact.

Beltrami Electric will implement the Operation Round Up program starting in May 2016. Members will see a separate line item on their billing statement

showing the amount that their bill was rounded up. As an example, if your bill was \$129.60, it would be rounded up to \$130, with the extra 40 cents going into the Beltrami Electric Trust.

All donations collected for Operation Round Up will be placed into the Beltrami Electric Trust and will be administered by a separate board of directors, made up of five members from our community who serve on the board on a voluntary basis (Beltrami Electric Trust board of directors as shown on front cover: Michelle Sand, *Bemidji*; Sharon Lembke, *Laporte*; Randy Frisk, *Bemidji*; Sherry Billups, *Blackduck*; Robert Smith, *Red Lake*).

"I am delighted to be selected to serve the communities within the Beltrami

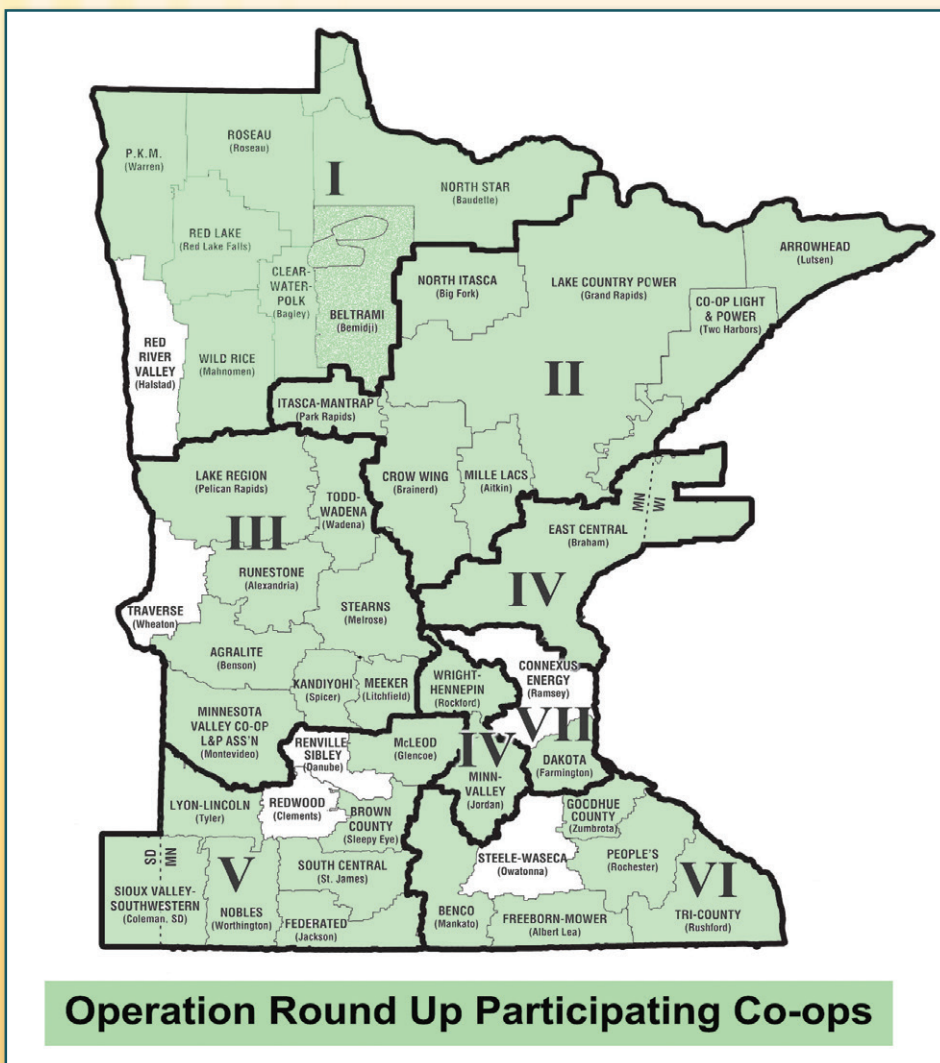
Electric Cooperative service area," said Beltrami Electric Trust board member Sharon Lembke. "I look forward to playing a part in contributing to the needs of our schools, responders, the different boys and girls clubs and responding to the unforeseen situations in a community where help is needed. I will try to be fair, responsible and trustworthy, and will strive to make decisions with those considerations."

The funding categories are as follows: Community Service, Economic Development, Education & Youth and Environment. Operation Round Up funds stay right here in our community and there aren't big administrative costs like you see with other nonprofit organizations. (Grants will not be made for lobbying, political and religious organizations, veteran, fraternal or labor organizations, fundraising dinners, raffles, capital fund campaigns, national fund drives, advertising or ongoing operational expenses.)

There will be an application process to receive a grant from the Trust and requests will be evaluated by the Trust board of directors. They will meet quarterly to evaluate all requests for funds and determine how they will be distributed. The total donations received from Operation Round Up, as well as grants awarded, will be announced in our *Northern Lights* member newsletter and on our website.

Later this year, eligible groups and organizations will be able to pick up an application in our office or download it from our website. They will then need to mail the completed application or bring it into the office in person.

Again, the Operation Round Up program is **VOLUNTARY**. If you do not wish to participate, you have several ways in which you may opt out. Q & A



The Beltrami Electric Cooperative, Inc. board of directors is pleased to announce a new community-oriented program called Operation Round Up. This voluntary program encourages members to round up "the change" on their electric bill to the next highest dollar with the money going into a trust for charitable community projects and local needs. To help you better understand the program, we have responded to some questions about Operation Round Up.

Q. What is Operation Round Up?

A. It's a charitable program designed to provide financial assistance to local nonprofit organizations and community projects. Co-op members can voluntarily participate by "rounding up" electric bills each month to the nearest dollar. What is most significant to us as cooperative members is this is an extension of how our cooperative was built over 75 years ago, with neighbor-helping-neighbor.

Q. How does Operation Round Up work?

A. This program is designed to "round up" each electric bill to the next dollar and use the additional change to fund the Operation Round Up program for charitable giving purposes. Although the individual change is a small amount, when combined with other participating co-op members, the potential impact could make a substantial difference in our communities.

Q. How much can members expect to contribute each year?

A. The average member donation will be around 50 cents per month, or \$6 per year, while the maximum annual contribution possible is \$11.88 per year. (This would only happen if your bill was rounded up by 99 cents for 12 months in a row.) Your contributions to Operation Round Up are tax deductible and will be shown on your billing statement.

Q. Why should I participate?

A. One should contribute only if they want to join other co-op members in a community development effort AND only if they feel they can afford to contribute an average of \$6 per year. Through a cooperative and unified program, members will have a means of donating to worthy causes, and, through Operation Round Up, the small change of individuals can add up and make a big difference for our area. Together, we can do some wonderful things for our local communities.

Q. What are some possible uses for the fund?

A. Examples of grants for funding would be local fire department equipment, youth and school groups and activities, local arts and education, senior citizen groups and many other various community programs and projects. Grants will not be going to large charities; they will stay in our community, for the benefit of our community. Contributions will generally be made only to nonprofit organizations that have been granted tax-exempt status under Internal Revenue Code Section 501(c)(3). For more information regarding funding guidelines, please see our website.

Q. Who administers the funds donated by Beltrami Electric members?

A. The Trust board of directors oversees charitable giving through Operation

Round Up. The Trust board is comprised of five members appointed by Beltrami Electric board of directors. The Trust board is responsible for reviewing applications and dispersing funds to local community organizations and projects. The board will meet quarterly to review applications for grants and disburse the funds. The Trust board of directors will evaluate and distribute grants within the following giving categories:

- Community Service
- Economic Development
- Education and Youth
- Environment

Trust board members volunteer their time and receive no pay or compensation for serving on the board. The directors will have staggered terms.

Q. How do we know where the funds go?

A. All donations collected from Operation Round Up will be placed in an account with the Beltrami Electric Trust. A list of program recipients will be published in the *Northern Lights* newsletter and on our website. There will also be an annual report for the Trust.

Q. How do charitable organizations request assistance?

A. Later this year, eligible organizations will be able to pick up an application in our office or download an application from our website. They will then need to mail the completed application to our office or bring it into the office in person. If the request is approved by the Beltrami Electric Trust board, a check will be sent to the organization. If you know of a local group or organization that would benefit from this program, please talk to them about Operation Round Up.

Q. When will this program start?

A. To give members who do not wish to participate several months in which to contact us, we will not be implementing this program until May 2016.

Q. If I have more than one account, will each be rounded up?

A. Yes, each account will be auto-enrolled. If you wish for only one account to be rounded up, you can choose to remove additional accounts from the Operation Round Up program by contacting our office at 218-444-2540 or 800-955-6083.

Q. What if I can't or don't want to participate in this program?

A. The program is always VOLUNTARY, and at any time, members can change their minds about participating. If you do not wish to participate in this voluntary program, you have several ways in which to opt out. Time is running out!

Beltrami Electric Cooperative's electric heating rebate program expires May 31, 2016. All equipment must be installed before that date. (Conservation rebates will continue through 2016.)

- \$20/kW rebate for the installation of a qualifying electric heating system that is on off-peak.
- Air-source heat pump incentive is \$100/ton – heating mode must be controlled on off-peak.
- Ground-source heat pump incentive is \$200/ton – heating

mode must be controlled on off-peak.

- Equipment must be new and off-peak systems must have a qualified backup.
- Homeowner will receive a rebate check after a visit from a Beltrami Electric technician.

Beltrami Electric's board of directors conducted its monthly meeting Wednesday, Jan. 27, 2016. All directors were present. Also present were General Manager Lynette Nieuwsma, Director of Finance and Member Services Sid Sletten and Executive Secretary Kay Olson.

The following reports were given:

- The manager gave the year-end 2015 report.
- Sid Sletten discussed nonoperating margins and reviewed the December and Year-End Financial and Statistical report, including work order inventories.
- The board was updated on the Operation Round Up program and thoroughly discussed member concerns.
- Dave Hengel, executive director of Greater Bemidji, gave a presentation to the board on economic development in the Bemidji area.
- Arlene Hogquist, Dan Edens, Sid Sletten and Sam Mason presented the operations year-end reports and reviewed the 2015 corporate balance score card with the board.
- Dan Edens reported on vehicle and lost-time accidents for 2015.
- The MREA District 1 meeting held Jan. 15, 2016, was discussed.
- Terry Difley reported on the last Minnkota board meeting.

The following actions were taken:

- Approved an investment in Greater Bemidji.
- Approved to record 2015 nonoperating margins, with the exception of G&T margins, as permanent, non-allocated equity as provided for under Article 6 Section 8 of the bylaws.
- Approved moving the February board meeting date to Feb. 22, 2016.
- All directors were appointed as delegates to the Minnkota and Square Butte annual meetings.

"Watt's Cooking?"

Pillsbury Chicken Rolls



Ingredients:

- 1 tube Pillsbury crescent rolls
- Parsley flakes
- Celery to taste, dice fine
- 2 C. chicken, diced
- Salt and pepper to taste
- Onion to taste, diced fine
- 3 Tbsp. butter, melted
- Small amount of cream
- 3 oz. cream cheese
- Crushed croutons (optional)

Mix cheese and melted butter until smooth. Add other ingredients except cream (only add cream if too dry). Press 2 crescent rolls together to make a square; seal perforation. Place ½ C. filling mixture on each. Fold up criss-crossing on top. Sprinkle with parsley flakes or crushed croutons. Bake at 325 degrees for 20-25 minutes. One tube of crescent rolls makes 4 servings (one each). - Submitted by Lois Hadrava of Bemidji, Minn.

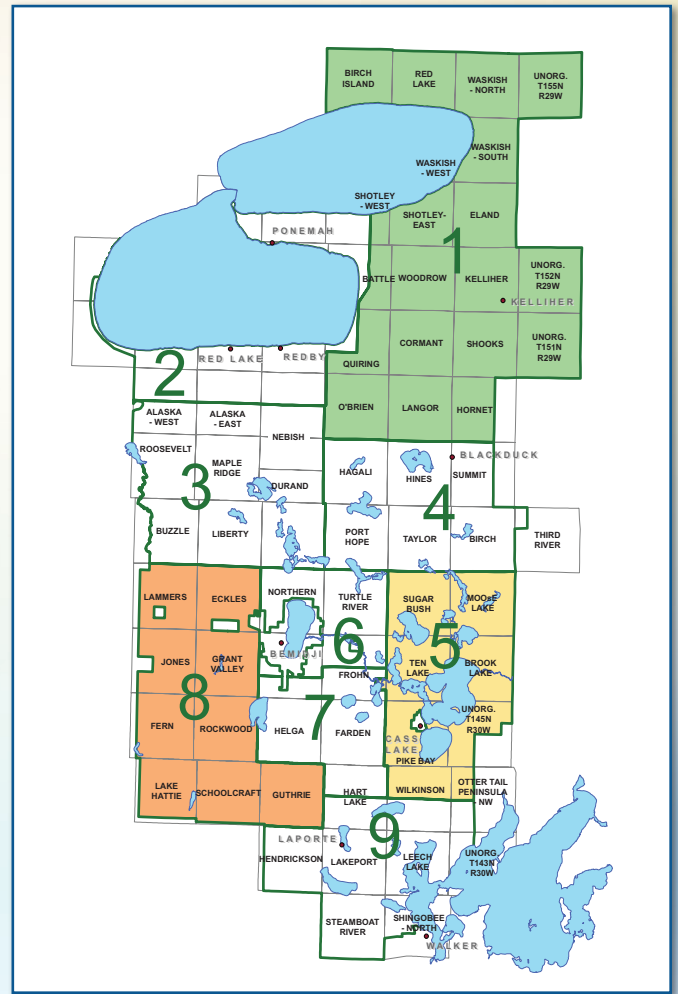
