Power On: October is **National Co-op Month**

s an electric cooperative, our top priority is always to provide safe, reliable energy to you, the member-owners we serve. Because we are a co-op, our mission is to enrich the lives of our members and serve the longterm interests of our local communities - and this mission has never been more critical than in recent months. One of the seven principles that guide all coops is "concern for community." To me, this principle is the essential DNA of Beltrami Electric Cooperative and it sets us apart from other electric utilities.

October is National Co-op Month, and electric cooperatives across the country are highlighting the many ways we "Power On." Keeping this theme in mind, I recognize the essential role we play in serving our special communities.

Who would have fathomed in March that the COVID-19 virus would amount to a test of our communities and our nation? The changing circumstances due to the pandemic have created both challenges and opportunities. Over the past several months, we've all been challenged to operate differently, and Beltrami Electric Cooperative has

stepped up to help our members and strengthen the safety net for our more vulnerable neighbors.

As an essential service, and to ensure reliability of your power supply, we modified our operations to safeguard business continuity. Our line crews and other employees began working on staggered schedules to maintain separation. Some employees worked remotely. In the office, we limited and modified meetings and gatherings to allow for safe separation. We also adjusted our walk-in office availability and in-person service calls to ensure the health and safety of our employees and our valued members. In addition, we have installed social distancing signage, Plexiglas barriers and hand sanitizers in our lobby. In these unprecedented times, we livestreamed the co-op's annual meeting on YouTube and held a small business meeting in our community room to conduct essential cooperative business. For the health and safety of everyone, we think these measures were the prudent course of action for the times.

And while we certainly missed



visiting with you in person, we found new ways to stay connected. We increased our social media presence, adding Instagram to our social sites. We utilized our E-newsletter and our newly updated website to communicate with members about operational updates and options to do business remotely.

I tell you about all of these efforts to explain how much we care about our communities – because we live here, too.

We've seen other local businesses

rising to meet similar challenges during this time, because that's what communities do. While the challenges caused by COVID-19 have been daunting, I'm heartened to see how everyone is pulling together.

In 1940, our communities built Beltrami Electric Cooperative to serve our communities, and that's what we'll continue to do – Power On.

Cold Weather Disconnect Rule

216B.097 COLD WEATHER RULE: COOPERATIVE OR MUNICIPAL UTILITY

Subd. 1. Application; notice to residential customer. (a) A municipal utility or a cooperative electric association must not disconnect and must reconnect the utility service of a residential customer during the period between October 15 and April 15 if the disconnection affects the primary heat source for the residential unit and all of the following conditions are met:

- (1) The household income of the customer is at or below 50% of the state median household income. A municipal utility or cooperative electric association utility may (i) verify income on forms it provides or (ii) obtain verification of income from the local energy assistance provider. A customer is deemed to meet the income requirements of this clause if the customer receives any form of public assistance, including energy assistance that uses an income eligibility threshold set at or below 50% of the state median household income.
- (2) A customer enters into and makes reasonably timely payments under a payment agreement that considers the financial resources of the household.
- (3) A customer receives referrals to energy assistance, weatherization, conservation, or other programs likely to reduce the customer's energy bills.
- (b) A municipal utility or a cooperative electric association must, between August 15 and October 15 each year, notify all residential customers of the provisions of this section.

Subd. 2. Notice to residential customer facing disconnection. Before disconnecting service to a residential customer during the period between October 15 and April 15, a municipal utility or cooperative electric association must provide the following information to a customer:

- (1) a notice of proposed disconnection;
- (2) a statement explaining the customer's rights and responsibilities;
- (3) a list of local energy assistance providers;
- (4) forms on which to declare inability to pay; and
- (5) a statement explaining available time payment plans and other opportunities to secure continued utility service.

Subd. 3. Restrictions if disconnection necessary. (a) If a residential customer must be involuntarily disconnected between October 15 and April 15 for failure to comply with subdivision 1, the disconnection must not occur:

- (1) on a Friday, unless the customer declines to enter into a payment agreement offered that day in person or via personal contact by telephone by a municipal utility or cooperative electric association;
- (2) on a weekend, holiday, or the day before a holiday;
 - (3) when utility offices are closed; or
- (4) after the close of business on a day when disconnection is permitted, unless a field representative of a municipal utility or cooperative electric association who is authorized to enter into a payment agreement, accept payment, and continue service, offers a payment agreement to the customer.

Further, the disconnection must not occur until at least 20 days after the notice required in subdivision 2 has been mailed to the customer or 15 days after the notice has been personally delivered to the customer.

- (b) If a customer does not respond to a disconnection notice, the customer must not be disconnected until the utility investigates whether the residential unit is actually occupied. If the unit is found to be occupied, the utility must immediately inform the occupant of the provisions of this section. If the unit is unoccupied, the utility must give seven days' written notice of the proposed disconnection to the local energy assistance provider before making a disconnection.
- (c) If, prior to disconnection, a customer appeals a notice of involuntary disconnection, as provided by the utility's established appeal procedure, the utility must not disconnect until the appeal is resolved.

Subd. 4. Application to service limiters. For the purposes of this section, "disconnection" includes a service or load limiter or any device that limits or interrupts electric service in any way.



Need help paying your electric bill?

The Energy Assistance Program (EAP) helps pay for home heating costs and furnace repairs for income-qualified households. We urge you to contact them immediately to avoid disconnection if you feel you are eligible for aid. (Eligibility is based on energy costs, household size and the three most recent months of income.)

This is to certify that the main source of heat for my home (more than 50%) is furnished by **permanently** installed Beltrami Electric Cooperative Inc. electric heating equipment (not portable) and I, therefore, am eligible for the electric heating sales tax exemption as provided by Minnesota State Tax Fact Sheet 157. This exemption is for the billing months of November through April only. *Exemption forms should be resubmitted every 3-4 years. Please notify us if you change from electric heat to a different primary heating source.

Electricity sold for residential use is not taxable for the billing months of November through April when sold to metered members who use electric heat as their primary source of residential heat. If more than one type of heat is used, electricity is not taxable if electric is the primary source of heat. Primary source of residential heat is the source that supplied more heat than any other source for the largest period of time during the heating season. Members with an off-peak meter are only exempted sales tax on the electricity that is recorded on the off-peak meter.

Some buildings have both residential quarters and commercial operations. If there is one meter for the entire building, the exemption applies if more than 50% of the square footage of the building is

residential. Complete and submit the following form only if you are eligible for the exemption. If you have more than one account, an exemption form must be filed with each location.

The State of Minnesota recommends the exemption forms should be updated and resubmitted every 3 to 4 years to be eligible for the exemption. Members who receive a tax exemption when electric heat is not their primary source of heat are in violation of the sales tax law.

Commercial accounts must use an ST3 form, which is available on our website.
