## Preparing for the big hunt: Consider electrical safety, too

As you prepare for hunting season, keep in mind that along with general hunting safety, electrical safety should also be top of mind.

You might be preoccupied and excited about the big hunt, but be sure to look up and out for power lines. Never place a tree stand near a power line. Contact with the power line, utility pole or related equipment can alter the path to ground, sending electricity through anyone or anything that comes too close or in direct contact with the power source. Even coming within 10 feet can cause an arc, transferring energy from the power line/source to an object or person.

In addition, do not shoot near or toward power lines, utility poles, transformers or substations. Stray bullets or pellets could damage equipment, possibly interrupting

electric service. Even more concerning, they could drop a power line to the ground, causing a hazardous scenario: Those who get within 50 feet of the downed line could be shocked or electrocuted.

Beltrami Electric Cooperative and Safe Electricity remind hunting enthusiasts of these electrical safety tips:

- Familiarize yourself with the area before heading out to hunt. Take note of power lines and equipment, especially when hunting in densely wooded areas.
- Observe all signs or postings that advise electrical safety, especially when scouting out a location for your tree stand.
- Do not use power poles to support a tree stand.

- Do not locate a tree stand near a power line or pole.
- Be in the habit of looking up and out for power lines and do not come within 10 feet of an overhead line or pole when setting up or taking down a stand
- Never climb a utility pole.

Please report any damage to a line or other related equipment to us so that we can address it. Although we perform routine maintenance, unless an outage occurs, damage may not be noticed for weeks or months due to the vast amount of lines that cover our service area.

Of course, always take the time to observe general hunting safety measures as well. Stay safe out there!

To earn a BLC, a director must have completed the Credentialed Cooperative Director Program, followed by additional courses covering subjects such as the cooperative business model, bylaws, ethics and political engagement. ## **Member privacy – Red Flags Rule**

As many as 9 million Americans have their identities stolen each year. As a result of that startling statistic, the Federal Trade Commission has developed a regulation called the "Red Flags Rule." The Red Flags Rule requires businesses to develop a program to detect, prevent and minimize the damage that could result from identity theft.



The data privacy of our members is important to us, and as a Beltrami Electric member, you may be asked to provide additional information and identification when you make inquiries on your account, such as verifying the last four digits of your Social Security number.

A member may complete an Authorized Contact Agreement form to allow us to give account information to others you want to have access to your account. This permits an Authorized Contact to make inquires on the account to which they are authorized. The Authorized Contact must provide their name, date of birth and the last four digits of their Social Security number in order to receive account information. While these practices may seem intrusive, please understand that these procedures are in place to protect your member data and prevent the occurrence of identity theft.

### **Daily cycling of electric storage** heat could begin in November

Members heating with electric thermal storage on the off-peak program – such as thermal storage room units, thermal storage furnaces or slab/in-floor heating - should turn on their heating system prior to Nov. 15 to allow a heat reservoir to build up before daily cycling of loads begins. The actual date daily cycling begins varies each season. Thermal storage heating is controlled each day from 7 a.m. to noon and 5 p.m. to 11 p.m.

It's hard to believe winter is right around the corner. Since weather conditions and future wholesale power prices make the amount of load control hard to predict, all of our members with off-peak heating systems are encouraged to have a reliable, automatic dual heating or thermal storage system in place and ready to use when you need it.

To ensure your total comfort this winter, consider the following questions:

- 1. Is the system sized to heat your entire home or business?
- 2. Does it maintain an adequate comfort level?
- 3. Is it fully automatic?

Check current fuel prices and be sure to fill your propane or fuel oil tank at the beginning of the season. Also, make sure your tank is large enough to hold an adequate supply. If your tank gets low during periods of extreme cold temps, it may not work properly.



## Operation Round Up® helps local programs

he Beltrami Electric Cooperative Trust Board for Operation Round Up® met in October to review 23 grant applications, which it received requesting funding for various local programs. The board awarded grants to 21 area nonprofit and community organizations totaling \$29,303.20. Many local programs and organizations benefit from Operation Round Up, a charitable program designed to give members a means of working together to use their small change to make a big impact in our local communities.

The average amount a member will contribute is 50 cents a month or \$6 a year, while the maximum annual contribution possible is \$11.88 per year. Contributions to Operation Round Up are tax deductible and will be shown on your billing statement. Participation is voluntary and members may opt out any any time or opt back in by contacting our office. The next application deadline is March 26, 2021.
