Powering Lives, Empowering Communities. That's this year's annual report theme. Fitting, considering that commitment to community and service to our members are core values.

## Annual meetina

Last year we conducted our annual meeting in conjunction with the Beltrami County Fair. It was immensely popular. So much so, we decided to once again partner with the Beltrami County Ag Association to host Beltrami Electric Night at the Fair, which will take place Wednesday, Aug. 10. We hope to see you there.

## The year in review

2021 was another great year for your cooperative. We constructed more than 300 new services and performed nearly 100 service improvements for our membership. Your cooperative continues to grow at a manageable rate. We also completed several major projects including line replacements near Dellwater Lake, Ardahl and the West Pike Bay/Guthrie area.

As a regional center, we continue to see steady growth year after year. Our economic development efforts continue to help our communities grow and prosper. We'd like to personally congratulate Bemidji Steel on its recent expansion within our service area.

## Sufficient margins

Revenue decreased by less than 1% in 2021, yet with overall system growth and controlling operating expenses, we ended the year with sufficient margins and met all of our loan covenants. We realized an operating margin of just over \$2.1 million and a total margin of over \$4.6 million. We also returned \$1.67 million in capital credits to current and former members in 2021.

#### Safe and reliable

Most importantly, our employees completed all of this work safely, while maintaining a reliable distribution system. On average, our members experience about one outage per year and our average service availability index was 99.98% – not bad considering our 3,000-square-mile service area and 3,500 miles of line. We did not experience a major storm in 2021 and we continue to be leaders in underground line construction with nearly 75% of our system underground. We are extremely proud of our employees for their commitment to safety and for providing the best possible service to our members.

#### Rate outlook

Our wholesale power rates remained flat in 2021 and our retail rates have not changed since 2018. This is remarkable when considering cost increases of just about every commodity we as consumers purchase. We may see an increase from our wholesale power supplier in 2023. We will know more by the end of the year and will evaluate if a retail rate increase is necessary. Approximately 67% of every dollar you pay on your electric bill goes toward the cost of wholesale power. We continue to see increases in material costs and significantly longer lead times. We are not immune to the inflationary pressure of raw materials, fuel and equipment.

## Looking ahead

2022 is the final year of your cooperative's three-year strategic plan. We surveyed our members in June to determine satisfaction levels and learn what is important to our members. We will use this information as part of our next strategic planning process this fall.

In closing, we would like to thank you for being a cooperative member and for your continued support. We would also like to thank our team of dedicated employees who work hard, day in and day out, to provide us with safe and reliable electricity.

# Annual Meeting Minutes - Aug. 11, 2021

# District Map and Election Bylaws



Beltrami Electric Cooperative only received one director nomination at each of the three district meetings held in June. Per your cooperative bylaws, the nominees listed on page five will be elected at the annual meeting scheduled for Aug. 10 by way of voice vote, show of hands or other appropriate means. With that, Beltrami Electric will **NOT** be sending to its members paper ballots via the U.S. Postal Service, nor electronic web ballots, in 2022. Please see the bylaws below.

#### ARTICLE III DIRECTORS

Section 9. Nominations and Elections. The areas served by the Cooperative shall be divided by and at the discretion of the Board of Directors into nine (9) director districts, and not less than ten (10) days nor more than fifty (50) days prior to the date of the annual members' meeting, and in accordance with the mailed notice to each of the members therein affected, district meetings shall be held at which candidates for the office of director from each respective district shall be nominated, and the names of the two (2) candidates receiving the greatest number of votes (including the number of votes cast for each of them) shall be certified to the annual meeting members.

At the annual meeting not more than one candidate from each district shall be elected to the Board of Directors. Election of directors shall be determined on the basis of a plurality of the votes properly cast.

Notwithstanding anything in these bylaws or applicable procedural rules to the contrary, a candidate who is the only qualified nominee for a seat up for election may be elected at the annual meeting of the members by motion adopted by a voice vote, show of hands or other appropriate means.

# 2022 Candidate Bios

## District 1: Murl Nord (Incumbent)



Originally from Bemidji, Murl graduated from Bemidji High School. He attended Bemidji State University, graduating with degrees in biology and chemistry. Murl and his wife, Sue, owned and operated a dairy farm for 30 years and he now farms with his daughter, Rachel, grazing beef cattle. Murl served 17 years on the Land O' Lakes corporate board, where he held the office of first vice president for five years and served on the executive committee for 10 years. Murl also served eight years on the national Milk Producers Association board, three years on the Minnesota Association of Cooperatives board and 25 years on the Blackduck school board. He was also one of the early organizers of the Blackduck Co-op. He resides in Hornet Township in Beltrami County and has two grown children and

four grandchildren. He was first elected to the Beltrami Electric board in 2010 and currently serves as secretary. Murl also serves on the Square Butte board of directors.

What qualifications do you possess that would make you a good choice to represent the members of Beltrami Electric on the board of directors? "I am a lifelong supporter of cooperatives as a way of doing business. I believe my experience on other boards has given me a knowledge base that allows me to understand the workings of BEC. I also have had numerous lobbying opportunities that are beneficial as our co-op faces many new government policy issues. I have worked to continue my education in the broad area of electrification and have completed the Credentialed Cooperative Director, Board Leadership and Director Gold programs offered by National Rural Electric Cooperative Association (NRECA)."

## **District 5:** Robert Wallner (Incumbent)



A member of Beltrami Electric for 44 years, Robert Wallner has been a general practice attorney in Bemidji for 44 years and raised beef cattle with his family for 39 years. He earned his bachelor's degree in economics and business from Bemidji State University and followed that with a law degree from William-Mitchell College of Law in St. Paul, Minn. He and his wife, Roxy, have five children and four grandchildren. In his spare time, Robert enjoys hunting, fishing and trapping, along with harvesting wild rice and collecting maple syrup. He also participates on the Bemidji Sr. Hockey team and enjoys working with his livestock and training his Labrador retrievers. Bob also serves on the Moose Lake town board.

What qualifications do you possess that would make you a good choice to represent the members of Beltrami Electric on the board of directors? "My experience operating a small business, along with my partners, involved long and short-range planning, meeting payrolls, managing accounts receivable/payable, budgeting for business operations and dealing with employee relations. My experience with our cattle operation has taught me the importance of having a strong electrical co-op to depend on. The last nine years on the BEC board of directors, along with completing the Credentialed Cooperative Director Program, have helped me to understand the electric business in general, and our co-op specifically."

## **District 8:** Sue Kringen (Incumbent)



A native of Bemidji, Sue received her bachelor's and master's degrees from Bemidji State University. She retired from Riverwood Bank of Bemidji where she served as the director of sales and marketing. Prior to that, Sue served as director of alumni relations and senior director of development for the Bemidji State University Foundation. Sue also served as the first full-time executive director of the United Way of Bemidji Area. She has served on the boards of directors for the Bemidji Area Chamber of Commerce, Bemidji Youth Hockey, Bemidji Gymnastics Club, the Salvation Army, the Bemidji Rotary Club, Lakeland Public Television and the United Way of Bemidji Area. Sue has been a member of Beltrami Electric for 43 years. She has served on BEC's board for District 8 since 2016 and currently

serves as the vice chair. She and her husband, Curt, reside in Fern Township in Beltrami County. They have two grown children and two grandchildren.

What qualifications do you possess that would make you a good choice to represent the members of Beltrami Electric on the board of directors? 




Minnkota electric generation capacity from wind and hydro energy

# **Operations Update**

The summer storm season started early this year. July and August are historically steamy, stormy months in Minnesota, but my radar weather app started showing red and purple on multiple occasions by the end of May this year.

When you're watching storm clouds and weather apps, those colors usually mean outage calls

because of trees or branches contacting power lines.

We live in the land of 10 billion trees, so it's hard to avoid outages when severe weather strikes and heavy winds blow. Despite this fact, we achieved 99.98% service availability index in 2021. That equals an average of roughly one outage per member in 2021 and an average restoration time of 88 minutes per outage.

The most important part of the story is that we operate and maintain 3,553 miles of line across six northern Minnesota counties as safely as possible day in and day out. The number of miles of line we oversee is nearly as far as it is from Anchorage, Alaska to Chicago, Ill., so safety is essential. It's a core value at BEC – for employees and members.

We have an employee safety committee that helps keep employees aware. And we engage in a proactive safety training program that is intended to keep employees of Beltrami Electric working safely every day while providing safe electric service for you. The emphasis on safety extends to everything we do whether working along the lines, inside the office, in a substation or in your front yard.

There are several reasons for resilient and stable reliability statistics:

**1. BEC employees.** The biggest reason for reliable service starts with a dedicated, motivated workforce that understands the mission of Beltrami Electric - which means we work every day to provide excellent value to members, the safe delivery of reliable electric service, excellent member service and innovative energy solutions at fair and reasonable prices. When outages occur, our employees take an "all hands on deck"



approach to getting outages restored.

2. We maintain thorough and careful clearing of trees and brush along power line corridors. Keeping trees cut, trimmed and clear of power lines ensures that you have the power to start the coffee maker nearly every morning and keep the ice cream

cold for a cool treat on a hot afternoon. Tree trimming and clearing is an important investment we make to keep your power reliable and dependable.

3. We also maintain strong reliability stats because 74% of our power lines are underground. Just like we do with overhead lines, we maintain a clear right of way above the underground lines



to ensure safe access, but underground makes a big difference when severe weather systems roll in, because trees fall – and we prefer when they fall safely to the ground above lines buried beneath the surface.

4. Investments in the distribution system – which include annual maintenance and capital work plan investments. BEC capital investments for equipment like underground cable, utility poles, overhead wire, transformers, trucks, meters and metering equipment make for a robust, reliable and resilient distribution system. And proactive line inspection and maintenance by the 24 BEC lineworkers and operations personnel help keep your power on nearly every day and almost every hour of the year.

Like nearly every other business, the biggest challenge we face this year involves supply chain for equipment and materials.

We have been working diligently to stay ahead of these challenges and have ordered materials far in advance for this construction season; however, there are long lead times on equipment such as transformers and fiberglass bases and pedestals.

Rising costs for materials, equipment and fuel have been impacting BEC and other electric utilities. As a result, we're working more efficiently and harder than ever to hold down costs to meet our mission and provide you with safe, reliable and affordable electric service 24/7/365.

As always, thank you for your membership (and your patience), especially when the storms roll through. Enjoy a safe summer.

# Off-Peak Adds Value Amid Concerns of Grid Reliability

Electric co-ops support, sustain and power rural communities, so the news about the possibility of "controlled power outages" (also called rolling blackouts) from the Midwest grid operator this summer is unsettling.

For the first time in my 30-plus years working in and around electric co-ops, we have

been asked to identify essential, or critical, loads because the grid system operator is predicting a shortage of power supply this summer.

Controlled, periodic outages may be implemented in the coming months to protect the power generation and transmission system. If peak conditions occur, temporary, controlled outages would be utilized as a last resort to help balance the supply and demand of electricity in the Upper Midwest if we end up short on power supply.

### Minnesota not immune

You might hear competing stories about why and how it's come to this, but a primary factor is that many MISO (Midcontinent Independent System Operator) members have shut down baseload power plants that operated 24/7/365. Most plants mothballed in the last 10 years were retired before their scheduled end of life because of changing market dynamics, the addition of wind energy and decarbonization goals.

As a result, Minnesota is no longer immune to large-scale grid challenges like we've seen in Texas and California in recent years.

The grid is increasingly reliant on intermittent and weather-dependent power supply resources, such as wind and solar. If the wind doesn't blow, and the sun doesn't shine, power supply does not always match demand - especially on hot, humid summer days when air conditioning use drives the need for additional power supply. MISO's peak demand for electricity typically occurs in the summer months during the hottest days of the year.

Closer to home, Minnkota Power Cooperative, BEC's wholesale power supplier, operates reliable generation assets that are an important contributor to the MISO system. Minnkota provides a diverse mix of coal, wind and hydro, and more than enough generating capacity to meet the

demands of its member distribution co-ops like BEC.

But Minnkota does not operate on the grid alone. Utilities across the Upper Midwest are connected through MISO. Emergency events experienced in other parts of the MISO region can and do have impacts that affect the Minnkota system and BEC members.

#### "All of the above" solutions

"Stewardship of all resources entrusted to our care" is a core value at Beltrami Electric. Supporting a cleaner, more sustainable energy future will require thoughtful planning and utilization of wideranging technologies to maintain reliability and achieve significant carbon reduction.

It will also take a willingness by state and federal regulators to allow investments in carbon capture technology for existing power plants to ensure grid reliability along with environmental sustainability. Minnkota's Project Tundra (an innovative carbon capture initiative) is an example of important technology improvements that will benefit reliability and sustainability goals.



## How can BEC members help?

BEC operates robust and effective off-peak heating, cooling and battery charging programs. By temporarily controlling electric heating, water heating and vehicle charging loads, BEC and its members can help shift electrical demand when other resources are limited or not available.



In the winter, cold-climate heat pumps (CCHP) absorb and transfer heat inside, and in the summer the units work in reverse, removing heat from the home.

Off-peak programs also provide members with options that put money back in your pocket with co-op rebates that reward investments in energy-efficient technology and lower overall monthly energy use. That means more bucks in your bank account to pay other bills and cover other costs.

We also offer a generator program called Generlink™, a meter collar device that allows you to easily connect a small generator to your home during power outages. Generlink is a cost-effective residential option that provides backup power to key circuits in your home - along with peace of mind when outages occur. More information is available at www.beltramielectric.om/generlink and on page 14 of this issue of Northern Lights.

If controlled power outages occur this summer, here's a "thank you" in advance for your patience and understanding while grid operators work out reliability, sustainability and affordability issues with regulators and politicians in the coming months, and quite likely, years ahead.

# Where Your Power Comes From

Coal and wind provide the majority of Minnkota's energy capacity resources. About 56% of Minnkota's capacity comes from coal, while about 34% comes from wind. The Langdon and Ashtabula Wind Energy Centers are located in eastern North Dakota. When you include hydro, about 42% of Minnkota's generation capacity comes from renewables. The hydro allocation comes from






